Installed exchange engine drive fuel pump on RH engine. Exchange unit P/N 646210-11 S/N B11LA857R from Aircraft Accessories of Oklahoma. Preformed Porta-Test SID 97-3G to set up proper fuel flows. During engine runs, engine would stumble. Strainer was clean but much debris was found in the fuel lines and in the RH selector valve. Removed debris and ran engine w/ porta-test, and ops check good. Ran without test box and set all idle/mixture as needed. Normal operation for the engine and no leaks noted. The maintenance described above, has been accomplished in accordance with current Federal Aviation Regulations and is approved for Return to Service.

Checked the cable tensions and lubricated all pivot points. Removed all the wheel assemblies, cleaned all wheel bearings, inspected, and packed with new grease. Serviced all tire pressures and installed the complete assembly. Checked the brake linings for serviceable wear and fluid leaks. Checked all internal and external lights, checked the stall warning and pitot heat for normal operation. Checked the ELT IAW FAR 91.207(d). Battery next due Aug 2021.

-Replaced LH and RH MLG door stops (PN 1241015-7). Adjusted stops as needed.

-Replaced LH and RH nose baggage door seals (PN R581496)

-Repaired fiberglass eroding issues and painted to match. LH horizontal, RH inboard wing, engine cowlings.

-Sheet metal repair skin on lower empennage as needed

-Replaced fuel sending gasket on RH nacelle tank (PN FCA25750)

-Repaired many pulled/working rivets on LH lower wing skin.

-Oxygen bottle was due hydro. Removed and replaced after hydro was completed by Aerospace Turbine Rotables, Inc. (WO 161579). Found cracked servicing line, replaced oxygen (PN S1721-12). No leaks noted after repairs. Oxygen bottle next due hydro 10/2025.

-Replaced LH and RH nav light bulbs (PN WL-A-7512-24)

-R&R LH strobe assembly with serviceable as removed unit from Dobson Aviation.

-Repaired LH deice boot line with same material.
